#### 2. Scenarios for Collaboration

Universities and Associations can join the EU4DUAL Alliance as Associated Partners, contributing to specific projects and accessing learning opportunities, or as Collaborating Members of the Dual Center of Excellence, offering a more flexible approach to collaboration beyond the established models of the European University Alliance. Both scenarios offer the potential for universities to transition to full partnership in future expansions of the alliance.

# 2.1. Integration of New Universities and Associations as Associated Partners

#### **Participation in Governance and Management Bodies:**

As an associated partner, your institution will actively contribute to the alliance's activities through participation in Work Package (WP) teams. While associated partners do not hold seats on the Governing Board, Rectors Council, or Academic Council, your involvement in WP teams ensures that your expertise is recognized and utilized in various projects and initiatives across the alliance.







#### **Exclusion from Future Legal Entity:**

Associated partners will not be included in the future legal entity of the alliance, which may limit your influence on high-level strategic decisions. However, your contributions to specific activities and projects will still be valued.

#### **No Direct EC Funding:**

Associated partners are not eligible to receive direct funding from the European Commission (EC) through the alliance.

#### **Participation as Mobility Partners in Joint Programs:**

Your institution can participate as a mobility partner in the alliance's joint programs, facilitating student and staff exchanges without taking on leadership roles. This allows you to expand mobility opportunities for your institution without the responsibility of program coordination.

#### **Collaboration in Research Projects:**

Associated partners are eligible to participate in research projects within the alliance supporting ongoing research efforts within Lighthouse Research Initiatives (LRI).

# Access to Microcredentials and Learning Opportunities:

Your institution will have full access to the alliance's microcredential programs and other learning opportunities, offering valuable development pathways for your students and staff, even with a limited governance role.

# Research, Innovation, Training, and Certification Services in Dual Education:

As an associated partner, your institution will benefit from the alliance's research, innovation, training, and certification services in dual higher education. This can enhance your educational offerings and research capabilities, helping you remain at the forefront of dual studies education.





# 2.2. Integration of New Universities and Associations as Collaborating Members of the Dual Center of Excellence

#### **Participation in Governance and Management Bodies:**

While collaborating members of the DCE do not hold seats on the Governing Board, Rectors Council, or Academic Council, your institution will contribute to the development of the Dual Center of Excellence (DCE) by participating in its activities.

#### **Exclusion from Future Legal Entity:**

Collaborating members of the DCE are not part of the future legal entity of the alliance, meaning your institution will not have a formal governance role in the alliance's overall decision-making process.

#### **No Direct EC Funding:**

As a collaborating member of the DCE, your institution will not receive direct European Commission funding through the alliance.

# Research, Innovation, Training, and Certification Services:

While collaborating members contribute to the alliance's research, innovation, training, and certification services in dual higher education, they are not directly involved in research projects that focus on the alliance's Grand Challenges.

### 3. Benefits and Opportunities for New Partners

Prospective partners will be evaluated on the resources and support they can offer to dual study programs and students, including mentorship, infrastructure, or financial backing.

#### **Quality of Apprenticeships and Internships:**

If offering apprenticeships or internships, partners must ensure high-quality, curriculum-relevant experiences with appropriate duration and learning outcomes for students.

#### **Networking Opportunities:**

Partners should have strong networks and be able to offer valuable connections to students, industry leaders, and other educational institutions within the alliance.

#### **Innovation and Adaptability:**

We seek partners open to innovation and able to adapt to the evolving needs of dual studies, contributing to the future development of dual education models.







#### **Ethical Considerations:**

All associated partners must uphold ethical principles such as integrity, transparency, and respect for intellectual property rights in their activities and partnerships.

- Proposed areas for collaboration.

- Application Deadline: 10<sup>th</sup> January, 2025.
- Interviews: 13-22th January, 2025.
- Final Selection: 3<sup>rd</sup> February, 2025.
